Filderstadt, 20 January 2025 – In the period from 13 January 2025 up to and including 17 January 2025, a total of 3,799 shares were repurchased under the Share Buyback Programme 2024 of All for One Group SE. The start date of the share buyback programme on 25 November 2024 was disclosed on 22 November 2024 pursuant to Article 5 (1)(a) of Regulation (EU) 596/2014 and Article 2 (1) of Delegated Regulation (EU) 2016/1052.
